MOTION FOR CIVIL CONTEMPT/ENFORCEMENT

Respondent requests that the Court enter an order of civil contempt/enforcement against Petitioner in this case because:

1. An Ex-Parte Order Compelling Discovery was entered on November 3, 2014. (A copy of which is attached hereto as Exhibit A.)
2. Pursuant to this order of the Court the Petitioner/Former Husband was required to fully answer the Request to Produce dated September 18, 2014, within ten (10) days.
3. The other party in this case has willfully failed to comply with this order of the Court. The Former Husband has failed to fully comply with said Request to Produce. The Former Husband provided a partial response on or about November 13, 2014, the undersigned contacted Opposing Party requesting the outstanding documents, no response was received.
4. The Respondent has incurred additional attorney's fees in bringing forth this Motion, which, but for the wrongful actions of Petitioner would be unnecessary. Respondent is unable to pay said fees and Petitioner should be required to pay for same.

WHEREFORE, the Respondent respectfully requests that this honorable Court:

- A. Find the Petitioner in willful contempt of court.

- B. Order the Petitioner to immediately file and provide complete response to the Request to Produce dated September 18, 2014.
- C. Enforce the prior orders of the court by any means available, including, but not limited to, incarceration, compensatory or coercive fines, garnishment, suit money and costs, and any other coercive sanction or relief permitted by law.
- D. Award the Respondent attorney's fees for necessity of this motion and hearing.
- E. Grant such other relief as the court deems just and proper.

EX-PARTE ORDER COMPELLING DISCOVERY


