**Possible Solutions:**

- Vote In More Good Judges:

- If a judge decides to strip someone's right to one's children, require a speedy jury trial.
- If a judge finds someone guilty of Domestic Abuse, require immediate transfer to Criminal Court with a speedy jury trial as well.



**How To Remove Bad Judges?**

- Having good candidates run against them. Close to 80% do not have any opposition, so they are automatically reelected without having to appear in the ballots.
- Appear for merit retention vote through constitutional amendment:
  - Via Legislature
  - Via Signatures.
- Ask Legislators to impeach worst offenders.

**Cartel/Racketeering Formulas For Fraud:**

- The more Foster Homes (FH), the more \$\$\$ the Family Court Cartel (FCC) gets: The > # FH → > \$ for FCC.
- The > # Adopted/Removed children → > \$\$\$ for FCC (\$4K-\$6K/child). Title IV-E Incentives \$410-\$486/month/child.
- The > # Child Support Orders (CSO) → > \$\$\$ for FCC (4 Billion from Federal matching funds).
- The > DV cases → > \$\$\$ for FCC
- The > Contested Divorces → > \$\$\$ for FCC (main reason why family law attorneys are advocating for Gay Marriages).
