On October 11, 2012 at 09:00am, I responded to 5700 SW 127 AVENUE #1316, where DONATELLA resides together with her parents. Contact was made with MR. JIMENEZ. I informed MR. JIMENEZ of the purpose for my visit. MR. JIMENEZ stated that he has been in a volatile custody dispute involving his ex-wife. MR. JIMENEZ stated that he has been harassed in the past and present by his ex-wife making false allegations to DCF. MR. JIMENEZ believes that the ex-wife found out that his current wife is pregnant and decided to make more false allegations.

MR. JIMENEZ stated that his ex-wife presently has full custody of his two children, which he has together with his ex-wife, due to DCF case number 2012-130103-01 that has been closed and awaiting a custody resolution in the court system. In the mean time, MR. JIMENEZ stated that his two children are being coerced by his ex-wife to make false allegations against him and that the children are starting to believe are true.

While interviewing MR. JIMENEZ, I observed DONATELLA playing with her toys located in the living room and interacting in a positive manner with both her mother and father. DONATELLA is a one year old and is non verbal. DONATELLA appeared well cared for and was free of marks or bruises, including no burn mark on her left leg as it was alleged on the DCF report.

Based on the information received and the observations made, this case does not rise to the level of child physical abuse nor does it warrant further law enforcement involvement and therefore is closed as such.
